Mitigating Civil Unrest and Promoting Civil Political Stability Across African Nations Amid Crises.

Iran, Israel and Yemen: a trifecta of political conflict.



Moderated Caucus on the agenda: **Examining the Effect of the United States' Gun Law on US and Neighboring Countries**, commences. The delegate of Israel raises some interesting points about the impact of Gun Law on the Gaza strip. The delegate of Sudan points out that the Gun Law is not necessary for any country. The draft resolution (1) was passed with clear majority, and the committee was adjourned for the day.

After a brief roll call, the United Nations Security Council moves forward with the GSL. The delegate of Iran points out Syria's militant organizations' well known involvement with the RSF of Sudan. The delegate of Egypt mentions SAF's involvement in genocidal wars and mass rapes, which was met with high critique. The draft resolution (1) was passed, as draft resolution (2) exceeded the number of signatories.

Brazil: Civil or Exploiting Other Countries?



The delegate of Australia raises a motion to start the GSL, on the agenda: **Combating Criminal Violence in Latin-American and Caribbean Region**. The Secretary General questioned the delegate of Israel about the bombing of the hospital which killed many members of Hamas, to which the delegate replied that it was a situation of war, and even Hamas is killing indiscriminately. The delegate of Italy referred to the refugees as a 'burden' for their country. The committee was adjourned.

The United Nations Human Rights Council began with the GSL, the motion raised by the delegate of Japan. The delegate of Brazil mentioned Brazil is helping other countries, like Jordan, by providing them with funds. Moderated Caucus was started, which followed a severe argument between the delegate of Israel and Palestine, among others. The draft resolution (1) was passed with clear majority, presented by delegate of USA.

Syria and Sudan: Hypocrisy?



The delegate of Bangladesh raises a powerful point – “Justice is delayed in India, does this mean justice is denied?” It was pointed out that Palestine is weighing patriotism and terrorism on the same balance. A ferocious battle took place between the delegate of Israel and the delegate of Palestine. Unmoderated Caucus was continued for 30 minutes. The draft resolution (2) was passed with full majority, before the committee was adjourned.

Following a roll call, the delegate of UK raised a motion to start the GSL for 60 minutes. The delegate of India was questioned, regarding the recent increase in crimes against women. The delegate of Somalia was also enquired, about the multiple critical loopholes which eradicate freedom of women. The delegate of Sudan was questioned about the concept of Marital Rape being practiced, which followed a dispute between the delegate of Sudan and the delegate of Syria.

A motion for Moderated Caucus on the agenda: **To Address the Inefficiency in the Proceedings**, by the delegate of New Zealand, was adopted.

BJP's Downfall?



After a rejuvenating lunch break, Rahul Gandhi raised a motion to start the Moderated Caucus on the agenda: **The Budget of 2024 and India's Economy**. He pointed out that the value of rupees is at its lowest. Nirmala Sitharaman counter-questioned by saying that they levied 98% tax in their time. A motion was passed to start the Unmoderated Caucus by Narendra Modi, which entailed numerous arguments. The committee was adjourned for the day.

After a brief roll call, a motion was passed to start the GSL, by Amit Shah. Narendra Modi was unable to tell the full form of ED, putting the entire government in doubt. Moderated Caucus was adopted by Rahul Gandhi, on the agenda: **Waqf Board**. Several heated arguments followed, which even resulted in Priyanka Gandhi's suspension from the committee for 5 minutes. Alka Lamba was unable to reply, when asked about 6th schedule, from Amit Shah.
